**Subject: Instructions regarding Re-evaluation in May 2018 Exam**

The result of all semesters for all regular and reappear students of May 2018 Exam has been declared on 25.06.2018 and is hosted on the website of the Board/HSBTE i.e. [hsbte.org.in](http://hsbte.org.in).

1. The students who are not satisfied with the result may apply for re-evaluation and for photocopy of the evaluated answer sheet on plain paper to their institutes along with requisite fees within the stipulated time.
  - a. Fees for re-evaluation of evaluated answer book : Rs. 200/- per subject
  - b. Fees for re-evaluation + photocopy of evaluated answer book after re-evaluation. : Rs. 1000/-per subject
2. The candidates who apply for the photocopy of his/her evaluated answer sheets will have to submit an undertaking in the attached format.
3. **The last date for the candidates to apply for the re-evaluation /photocopy is 02.07.2018.**
4. All the data regarding re-evaluation / photocopy should be uploaded by the institutes by 02.07.2018 in the PCA Software (downloadable on the website of the Board/HSBTE i.e. [www.hsbte.com](http://www.hsbte.com)). The site will be closed on **02.07.2018 at 7:00 pm**. The Principal of the institute must ensure that all the data regarding re-evaluation/photocopy is uploaded timely on the PCA Software.
  - a) **Students should deposit the fee to their institute.**
  - b) The fees collected from the students must be deposited by the concerned institute only **through Payment Gateway/Checking/Photocopy fee**  
"at [www.hsbte.com](http://www.hsbte.com) using **Net-Banking/ Credit Card / Debit Card**.
5. No application for re-evaluation from students will be accepted in the office of HSBTE.
6. No Data uploaded by the institute regarding Re-evaluation will be entertained by the Board after the closing date. The data sent by e-mail or by post will not be entertained in any case.
