<b>(i) Submission of PCA forms by the students to their respective institutions</b> <b>(ii) Uploading of PCA forms by the institutions.</b>	17-19 July 2018
<b>Examination Fee</b>	Rs. 250/- per semester for batches 2012 Rs. 1000/- per subject for batches before 2012
<b>Print of Admit Cards:</b>	20.07.2018 & onwards
<b>Exam dates of Special Exam:</b>	21, 22, 28, 29 & 30 July 2018 (Datesheet shall follow separately)
<b>Tentative date of result declaration of Special Exam:</b>	10.08.2018
<b>Exam Centres</b>	Only in Govt./ Aided Polytechnics

3. **Students of all polytechnics but only upto 2015 batch having one / two reappears in the above said subjects are allowed to sit in this Special Examination to clear their Diploma. Students of 2016 & 2017 batches are not allowed for this special examination.**
4. PCA forms of the students shall be uploaded by the respective institutions.
5. Institutes must not upload PCA of students in that subject in which they have been already declared pass.
6. As this is a Special Examination being offered to the students, hence no rechecking shall be allowed for this examination.
7. All the institutions must ensure to upload correct subject ID from the above mentioned subjects. No request for correction of subject IDs shall be entertained by the Board after the last date of uploading of PCA forms.


