The student has cleared all the examinations of the 1st Semester,

OR

The student has passed at least 50% of the total examinations conducted from 1st to 3rd Semester.

Students who do not fulfill the above criteria shall not be eligible for promotion to the 5th Semester under any circumstances. All students are advised to check their examination status carefully and ensure compliance with the above rules.
